To underwrite the costs of the 2024 Festival from Town Council funds up to £2,000.</li> <li>e. The Town Council to act as Temporary Events Notice Licensee</li> <li>f. To appoint a representative of the Town Council to the 2024 Festival Working Party</li> </ul>

g. The proposed budget for the 2024 Festival is presented to P&R for its consideration and to inform its decision on the percentage to be paid to the Mayor's Charity Fund.
