FC/23/100 To appoint additional member to Policy & Resources, Community & Town Promotion and Burial Committees following resignation of Paul Smith.

Following a secret ballot, Cllr Slade was elected onto Policy & Resources.

FC/23/101 To consider Civic Event as part of Athelstan 1100 event (report Cllrs Ritchie, Grant & Exton)

Following discussion it was resolved to accept the proposals,

- (i) Malmesbury Town Council agrees to lead the organisation of a Civic Event to mark the start of the commemoration and celebration of Athelstan 1100.
- (ii) The organisation of the Civic Event, including the date of the event in June 2024, the nature and scope of the event, the extension of invitations to attend, and the specification of one or more permanent markers of the Anniversary, is delegated to the Mayor, Deputy Mayor, Chair of P&R and the Town Clerk, with a mandate to include other MTC Committees, Councillors and Athelstan 1100 event organisers as required.
- (iii) Funding requirements for the Civic Event and the permanent markers are identified and included with MTC budget proposals for the Council Year 2024-25.

FC/23/102 To appoint additional members to Climate Strategy Working Group

Following discussion it was agreed that Cllrs Slade, Ritchie, Hastings and Whatton would be on the Working Group and that they would convene a meeting as soon as possible.

FC/23/103 To consider MTC support for 9 Regiment (report Cllr Grant)

Cllr Grant had circulated the report ahead of the meeting. It was resolved to allocate £450 towards the recognition of exceptional service. £300 for 6 gift cards and £150 towards cinema tickets.

FC/23/104 To consider Malmesbury Town Council's relationship with Tetbury Town Council (report Cllr Grant)

A meeting had recently taken place between The Mayor, Deputy Mayor, Town Clerk, Deputy Town Clerk and their Tetbury counterparts. The meeting prompted a desire to work closely with Tetbury as similar towns with similar issues. It was agreed that members support this approach and look forward to working together.
