The Council of the County of Wiltshire in exercise of its powers under Sections 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended ("the 1984 Act") and the Traffic Management Act 2004, as amended ("the 2004 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following Order.

1. The County of Wiltshire (Northern Wiltshire) (Off Street Parking Places) Order 2022, (hereinafter referred to as "the Order of 2022") shall be amended by:-

The addition of the following Article;

'14A. In a Pay and Display Parking Place a vehicle displaying a valid Blue Badge shall be entitled to one extra hour of free parking in addition to the time allowed following payment of the appropriate charge in accordance with the scale of charges specified in Schedule 1 to this Order.'

2. This Order shall come into operation on xxxxxxxx 2023 and may be cited as The County of Wiltshire (Northern Wiltshire) (Off Street Parking Places) Order 2022 (Amendment No.1) Order 2023.
