It was resolved to Support the nomination of Freemasons Hall (The Masonic Hall), Silver Street, Malmesbury to be listed as an Asset of Community Value.

Update on Bloor (Filands Appeal)

Cllr Exton attended the recent Appeal hearing. The Appeal allows Bloor to maintain the two planning applications as 'live' although there is written confirmation they would prefer to manage the sites under one masterplan, which was discussed at several meetings we held with Bloor. It was also noted Wiltshire Council had not completed the Section 106 agreement in the required timescale. We await the Inspectors report. It was agreed Dep Town Clerk will contact Bloor to request an update to any discussions after the Appeal hearing.

Update on Park Road site

There is continued concern regarding the lack of flood and drainage information on the Reserved Matters application which has been requested from the developer. It was agreed we will seek an update from Cllr Grant in the first instance and then consider contacting Wiltshire Council, the planning officer leading on the application and the developer.

Update on second Park Road site

No application has been submitted as yet, we do have details of the site owner and would want to open a dialogue regarding flooding and the Section 106 agreement. We will continue to keep this site under review.
