MAYORS ANNOUNCEMENTS His Worship, Cllr Paul Smith reported;

Wiltshire Association of Local Councils & Society of Local Council Clerks – nothing to report.

Market Town Forum - nothing to report. It was suggested that this should now be removed from the list as it is unlikely that the forum will reconvene.

Malmesbury Conservation Group – discussions are being held with the Diocese regarding the embankment leading up to the Town Walls. This was on the agenda for the last P&R meeting. Frances Goldstone has retired from MRVT and it was suggested a letter of thanks should be sent to her on behalf of the Council and the town. Restoration needs for the Market Cross have been discussed. A review of empty properties in the town is also taking place.

Malmesbury Town Team – The Gift Card is being rejuvenated and relaunched to encourage "shop local". The Dyson Foundation are going to support a new trail on Explore Malmesbury. Activity supporting Renew Malmesbury and also looking at planning changes and their impact on the High Street

Malmesbury and District Twinning Association – Plans are being made for a trip to Gien and a return visit from Niebull

Operational Flood Group – First Aid and Manual Handling training has taken place.

Community Area Transport Group - nothing to report

Local Youth Network Management Group – Cllr Vandelli was not in the meeting to provide an update

Movies at Malmesbury – it is hoped the bar will be open from Dec 6th

Malmesbury Climate Action Network (inc Malmesbury Against Plastic) – Cllr Vandelli was not in the meeting to provide an update

Athelstan Statue Project Group – held a very successful Wessex Week last month **Joint Parish Neighbourhood Plan** – Cllr Power reported on the informal consultation and the review. The Neighbourhood Planning Officer at Wiltshire Council has recommended delaying the formal consultation until January.

FC/21/94 To receive an update from the Wiltshire Councillor Gavin Grant.

Cllr Grant reported on;

 The delay to the meeting to discuss the Malmesbury Town Centre and High Street Support Action plan. He is pressing for the meeting to be scheduled before the end of the year

- His role with regard to the Community Governance Review. The Town Clerk has contacted Brokenborough to involve them in the discussions. The deadlines are tight as key deliberations will take place before the end of the year
- The Strategic Planning Committee is due to meet on Dec 1st to consider the planning application for 26 houses on Park Road. Cllr Grant will attend this meeting to make the case for rejecting the officer's recommendations. He is also planning to oppose the application by Gleeson for a site at Filands. He is, along with Cllr Ritchie, supporting local residents in their opposition to the appeal regarding the gabion wall
- All of these planning issues indicate there will be more pressure from developers in 2022 and the Council will need to consider how to address future planning applications.
- The Local Youth Network will now be meeting monthly. The Community Safety Forum will be meeting bi-monthly. There will be extra Community Alliance meetings to look at speed enforcement and footpaths and cycle tracks

The meeting closed at 8.40pm
