FC/21/103 To receive report from CIIr Doody on Bus Transport in the Malmesbury Area

In addition to Cllr Doody's report Cllr Grant reported he had raised this issue with the Cabinet member responsible on Wiltshire Council. There has been some confusion over the funding for bus services as the Government financial support has been withdrawn. The Cabinet member is writing to the Government to seek a continuance of the funding.

FC/21/104 To consider Freedom of the Town event with Buckley Barracks (Cllr Grant)

The 9th Regiment Royal Logistics Corps were given freedom of the Town in 2010. Since then, there had been a proposal to sell the Buckley Barracks site, but the Government has decided not to do that now. The Regiment is keen to engage with the town although they are due for a posting to the Continent in late spring next year. To date there has not been an opportunity for the Regiment to exercise their Freedom of the Town rights to march and parade through the town. If possible, the Regiment would like to do this before they leave for the Continent.

Resolved: Cllr Grant to work with the Regiment to organise an opportunity for them to march through Malmesbury. A coin to recognise the event would also be given to all involved from the Regiment

FC/21/105 To approve precept request proposal from Policy & Resources (1st December 2021)

Cllr W Jones covered the essential points for consideration, reporting on behalf of the P&R Committee who were recommending a 2% rise in the precept as outlined in the report. Detailed discussions on the budget and reserves had taken place at the last P&R Committee meeting and the recommendation was made taking account of the pressures likely to be felt by residents.

The precept requirement is for £476,710.58. The tax base is 2175.37. The Band D rate will be £219.14 which is a 2% increase.

Resolved: to accept the P&R Committee's recommendations for the budget and 2% rise in precept for 2022/23.

His productive and positive meeting with Victoria Moloney from Wiltshire Council.
 There seem to be a number of opportunities to progress the plans drawn up earlier in the year, with a potential £10k pot to be spent by March 2022.

Resolved: that the High Street Working Party should meet early in the New Year to look at how the potential grant could be spent

Proposed: Cllr Grant Seconded: Cllr Power

- The Community Governance Review is in full swing with over 100 replies to the online survey. Cllr Grant stressed the importance of prompting Malmesbury residents and those of St Paul's Without to complete the survey
- The Strategic Planning Committee rejected the second site on Park Road. Appeals on both sites should be expected
- The Area Board has approved a grant of £5k towards the cost of installing CCTV in Malmesbury.

Cllr W Jones asked if he could be included in the Community Safety Forum

Finally, the Mayor announced the retirement of Graham Jobes, and thanks were expressed by all the councillors for his contribution to the town.
