Cllr Exton presented his report to members. Following discussion, it was agreed that more detail is required from residents of Parklands with reference to the heavy plant machinery/traffic. It was agreed that the request for double yellow lines at Baskerville would continue. The issue at the Island by Filands Estate was also discussed and members agreed that this should have been covered by Wiltshire Council Highways when the development was built; it is not the responsibility of MTC but fall under the remit of the Community Infrastructure Levy.
