It was agreed that the Rule 6(6) status application would continue.

P&E/22/34 To consider request to forward Highway Issue at the Mirror Bend with damage to properties from HGVs

The report was noted. Following discussion it was agreed that there is no simple solution to the issue. It was agreed that it would be passed to CATG but members believe that a technological development for traffic monitoring would be required. Automatic Number Plate Recognition could be installed at two sites in the Town and could lead to prosecution of repeat offenders of HGV drivers coming through the Town Centre.

The Clerk will write to the resident who has expressed grave concerns.
