Comment – Whilst we agree the condition of this tree requires its removal, we would hope a similar replacement tree or shrub would be planted in its place.

PL/2022/08279 - 7 Katifer Lane

Comment - As a dwelling in a prominent location in a Conservation Area, we refer this application to the Conservation Officer (we believe there may be a precedent of not allowing UPVC products in this area).

PL/2022/08603 - 24 Horsefair

Comment - Whilst we agree to the removal of the tree, we would hope a similar replacement tree or would be planted in its place or in the vicinity.

20/08618/FUL - Lane west of A429 (Crudwell Road)

Comment - We still have concerns as per our previous comment below and would request a response so we are able to make a proper informed decision.

WC-21-05-197106 - Following discussion at its meeting on the 4th May it was resolved that Malmesbury Town Council has concerns over the density of land being used for energy production rather than food and asks if there is a policy adopted by Wiltshire Council that is used to determine such applications.
