Wheeler Way

The recent meeting online on 2/10/25 with various departments at Wiltshire Council was positive and next steps will be Wiltshire Council mapping the agreed route of the which will link the pathways and improve connectivity. This will enable a costing to be produced and further information will follow.

Dual recycling Bins for general refuse/recyclables

The internal handles have been fitted ahead of the estimated date of 31st October. A vehicle with lifting capabilities will be hired to assist with the installation process and removal of old bins and it is hoped this will be completed within 4 weeks due to availability of the vehicle and staffing. Wiltshire Council owned bin from Birdcage Walk will be relocated to new site at Backbridge Farm (Wiltshire Council have agreed to this and the bin will be emptied by Town Council staff). It was agreed to consider additional bins at the next meeting during budget setting.

Speed Indicating Devices

Speed surveys have been requested to 3 locations.

Malmesbury River Management Plan

Initial contact has been made with various stakeholders and community groups. It was agreed to arrange a meeting for Fri 14th November.

Market Cross

Next tranche of works is being progressed, surveyor will be required to create a specification of works for tender by specialist companies and this will assist with budget setting. It was requested that the survey report is recirculated to councillors.
