Land to the north of Whychurch Farm and to the south of Filands, Malmesbury

Malmesbury Town Council strongly objects to this application (Called In).

It is outside of the Malmesbury Neighbourhood Plan.

It is in excess of NPPF housing numbers for Malmesbury.

It will have a detrimental effect on traffic and congestion. The location with lack of footpath provision will contribute to reliance on car transport.

It will have a detrimental effect on education and medical services.

The loss of green space will have a detrimental effect on biodiversity and hedgerows.

The development makes little provision for social and economic space.

Please note Malmesbury Town Council endorses the statement of North Wiltshire Swifts.
