#### PE/25/090 Election of Chair to P&E Committee

Vice Chair P Exton opened the meeting. Nominations were requested for the vacant position of Chair. Cllr P Exton was nominated and agreed to stand. With no other nominations forthcoming and following a unanimous vote, Cllr Exton was elected as Chair to P&E Committee.
